UNIVERSITY MUSIC EXAMINA-TIONS.

After occupying six days the public examinations at the University of Adelaide in the practice of music have been concluded. Last year the total entries for these examina- : tions were 49. This year the total number, was 111, or an increase of 62. Of these 99 entered for planoforte-playing, 39 obtaining first-class certificates and 44 second-class certificates, whilst 18 failed. Twelve candidates entered for singing, 7 passing first class and 4 second class, with 1 failure. The only candidate for violinplaying was placed in the second class. These results are highly creditable to the teachers. Professor Ives, Mus. Bac., the examiner, says that the candidates generally were well prepared, but that some of the teachers were not half aware of the requirements in regard to scale-playing. Perhaps it would be as well if they communicated with the Professor on the subject. In some respects the playing of the candidates showed an advance upon that of last year. With reference to the singing, there was rather a disposition to force voices and to bring pieces beyond the ability of the candidates. THE UNIVERSITY.

At a meeting of the University Senate to-day five gentlemen are to be elected to fill vacancies in the Council. The retiring members are proposed for re-election, and in addition three gentlemen who have not before held office seek the suffrages of the Senate. All the candidates are men of weight, and one only regrets that a selection must be made. With the exception of one gentleman, all are graduates in Arts, Law, or Medicine. The Divinity School is not represented, but this is because the Council has already the requisite number of divines to surround its deliberations with the halo of respectability. There is really, then, an embarrassment of riches, and whatever five members are elected, the public may be sure that the addition to the governing body of the University will be of a useful and satisfactory character. When the contingency arises that candidates for posts are all of high merits, the only point upon which electors should insist is that, other things being equal, those men should be selected who have most time to give to the performance of their important duties. In times past there has been too much of a tendency in Adelaide to choose governors of institutions from a comparatively small circle. It was as if there were certain vested rights to be respected, and that it would never do to pass over a man who has already served, or who is at the time engaged in several other works of public utility. This monopoly of honorary work is not a good thing. It tends to make the monopolists think more highly of themselves than they ought to think, and to imbue them with the idea that criticism of the acts of the Boards on which they serve is dictated by personal hostility to themselves. When we consider the matter seriously, it cannot but appear that the fact of a man having to serve the State in many different capacities is no guarantee that he can serve the State in another. The University is growing apace, and, if the increasing work is to be accomplished satisfactorily, the Council should be composed of men who are not trammelled by official obligations, and who have plenty of time to devote to the

discharge of their important duties.
